## **Publication of a transparency notification received by KBC Ancora SCA**

(Section 14, first subsection, of the Act of 2 May 2007 on disclosure of major holdings)

### **Summary of the notification**

KBC Ancora has received a transparency notification dated 31 May 2018 indicating that BlackRock Inc., by virtue of acquisition of financial instruments that are treated as voting securities, has surpassed the notification threshold of 1%.
